Once all documents are signed, your cabinet order will be placed into production. Another 40% is due prior to installation, with the final 20% due at the time of installation. |

It is understood that Toulmin Cabinetry, Inc., retains exclusive ownership to the copyrighted floor plans, elevations, technical drawings, perspectives, and any other plans related to the installation of cabinets, and/or your remodeling project. Plans are licensed to you, not "sold." Use of these plans is protected by the U.S. copyright laws. These laws apply to you, your builder, your remodeler or any other agent acting on your behalf. This agreement is entered into by and between Toulmin Cabinetry, Inc., an Alabama corporation, ("Designer"), and ("Client"). Client does hereby deliver to Designer the sum of \$ _____ (the "Deposit"). This Deposit shall be applied toward the total contract price of the cabinetry, on projects of \$5,000 or more. In the event that the client does not fulfill this agreement, the Designer may keep the Deposit as a fee for assisting Client with preliminary designs.
